#### • Public Comments:

- Linda Jeffords Asked about Cal Trans work on Marysville Rd and if it would be continuing up to Texas Hill Rd. Cal Trans does not work on County Roads perhaps contact Public Works?
- Charles Sharp Announced that Fire Protection District is in discussions with the Yuba Water Agency to conduct a Feasibility Study in which Fire Protection Tanks would be installed. The Yuba Water Agency will fund the study.
- Special Presentation: Nora Cooper; Operations Center Manager, ALERTCalifornia Operations Center
  - Nora Cooper spoke about what the ALERTCalifornia program is doing with regard to fire detection technology. <u>ALERTCalifornia.org</u>
    - ALERTCalifornia is a UC San Diego public program with a fire camera network of 1000 PTZ cameras with 360-degree views across California. Operation Center is based in Chico and funded by many sponsors such as Cal OES, UCSD and CalFire
    - ALERTCalifornia is branching out into other states and has become the largest camera network with 6000 cameras.
    - The system has a log-in for First Responders to access all features of the system.
    - The public also has access to the system at: ops.alertcalifornia.org/secure/camera by using the "Active Cameras" button.
      - O People can see all cameras California by moving around the state on the map.
      - o The Map Legend shows all accessibility features.
      - A visitor can make a camera set for the camera in their area.
      - Can toggle off-line cameras at: status.alertcalifornia.org
    - Cameras operate 24/7, keeping metrics on response times.
    - Raw AI is used for locating fire by pin location with lat/long, is reviewed by staff, then sent to first responders. It's also focusing on filtering out false positives.
    - No estimated timeline for a phone App yet but you can access it by web browser.

- USFS-Tahoe National Forest Gabe Foster/ Chris McCandless, YRRD District Fuels Specialist
  - Fire Update

- Big News: Helicopter 514 off Whitecloud qualified as a repel today. First time in a decade we have stood up a new repel crew.
- Type 1 Airship which is a tank type ship based in Truckee.
- Air Attack 17 is based in Grass valley.
- o Initial Attack Fires: There were a round of small fires due to last week's lightning all kept to under 3/4 acres.
- o All engines are staffed, All Hot Shot Crews active and Saddleback is fully staffed.
- Conducted 33 acres of under burn in North San Juan about 3 weeks ago. It is at patrol status as of now.
- o Burn Ban is in affect now by the state.
- Forest Staffing is at Level 5.
- Still allowing campfire in the Tahoe National Forest as of now.
- Other Big News: The 275,000 acre North Yuba Forest Landscape Resiliency Project EIS was signed today in Downeyville.

## Ongoing Projects

- o Hazard Tree Removal continuing in campgrounds.
- Trapper Streamflow Enhancement in Camptonville clearing continuing 600 acres completed.
- Trapper Pack going out for contract next month.
- The New Bullard's Bar Project is moving forward. Waiting for release of grant funds from CalFire.

# • Natural Resources Conservation Service – Diego Camacho Molina

- EQIP Cost Share Forestry Applications done for the season/fiscal year. 3 out of 14 applications were approved. Hoping for a better ratio next year.
- Conservation Stewardship Program is open (see website nrcs.usda.gov for qualifications)
- The forester from Ukiah will be covering while we look to hire a new forester.

#### • Executive Director Report – Allison Thomson

- Stevens Fund Fuelbreaks: The Brownsville-Oregon House grant agreement was finally signed, just in time for the hot, dry weather. When it is safe to do so, our landowner partners can get started on that next phase of fuelbreak.
- Roadside Fuel Reduction Project, Dobbins/Oregon House: The June community meeting
  was canceled last minute due to the Scott Fire. The meeting will be rescheduled soon
  and announced through our email list and our Facebook group.
- New public comment period open for Cal Fire's Fire Hazard Severity Zone update. The original public comment period was this past winter and early spring. They then made some additional updates to the map based on those comments, so they're opening a new public comment period. There were no new changes to Yuba County.
- Forest Business Alliance workshops
  - o Great sawmill workshop in June with great attendance and great feedback
